

## Regulations of the contest „7 Boxes for 7th Anniversary”

### 1. How do we understand the following terms?

Definitions used in the Regulations of the contest "7 Boxes for 7th Anniversary " have the following meanings:

- 1.1 Contest:** „7 Boxes for 7th Anniversary”;
- 1.2 Committee** - a committee appointed by the Organizer, consisting of 3 representatives of Prouvé, whose task is to oversee the proper conduct of the Contest and to select the Winners, as well as to consider complaints;
- 1.3 Prouvé (Organizer)** - Prouvé spółka z ograniczoną odpowiedzialnością sp. k. with its registered office in Wrocław (postal code 53-012) at 56H Wyścigowa Street, entered in the Register of Entrepreneurs of the National Court Register kept by the District Court for Wrocław-Fabryczna in Wrocław, VI Economic Department under the National Court Register number: 0000665414, NIP: 8992810863, REGON: 366657707;
- 1.4 Regulations** - Regulations of the Competition "Feel freedom in singles, learn love in duos", available on the website at: [www.prouve.com](http://www.prouve.com) on the profile "Prouvé Official" on the social network Instagram and at the headquarters of the Organizer;
- 1.5 GDPR** - Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation);
- 1.6 Participant** - an adult natural person with full legal capacity, participating in the Contest;
- 1.7 Winner of the Contest** - the Participant who has been awarded the prize under the terms of the Regulations.

### 2. What are the general rules of the Competition?

- 2.1.** The contest is organized by Prouvé and is valid only on the social media platform Instagram.
- 2.2.** The contest runs from 07.05.2024 r. until 28.05.2024 at. 12:00 am.
- 2.3.** Taking part in the Contest by the Participant means acceptance of the provisions of these Regulations.
- 2.4.** The winners of the Contest will be the Participants who, during the term of the Contest, fulfill the conditions of the Contest specified in the Regulations, including correctly completing the Contest tasks specified in the provision of point 3.3 below.
- 2.5.** The results of the contest will be announced by 29.05.2024 r. on the social network Instagram in the form of "stories" at @prouve\_official.

### 3. What are the prizes, competition tasks and additional conditions of the Competition?

- 3.1.** The Contest is open to Participants who complete the contest task specified in the provisions of point. 3.3.
- 3.2.** The prize in the Competition is one of the seven sets of Prouvé products listed below:

  - 3.2.3.** Two sets valued at 589 PLN each, consisting of: Organic freeze-dried instant coffee, Black leaf tea Golden Yunnan GFOP, Water Bottle, Bronzing elixir for face, neck and cleavage, Daily shaping body lotion, Roll-On Deodorant, Classic Woman’s Perfume,, Classic Men’s Perfume, Food supplement - Vitamin C from rose hip
  - 3.2.4.** valued at 589 PLN each, consisting of: Organic freeze-dried instant coffee, Black leaf tea Golden Yunnan GFOP, Water Bottle, Bronzing elixir for face, neck and cleavage, Daily shaping body lotion, Roll-On Deodorant, Classic Woman’s Perfume,, Classic Men’s Perfume, Food supplement - Energy and Vitality.
- 3.3.** The competition task involves:
  - 3.3.1.** Publishing an interesting, original Instagram video clip showing how Prouvé's 7th anniversary is celebrated, tagging Prouvé in it, not exceeding 30 seconds;
  - 3.3.2.** Adding a comment under the competition post, tagging 2 people in it,
  - 3.3.3.** Sharing the competition post on your Instastories and adding the hashtag #Prouvé7Birthday.
- 3.4.** After the end of the Competition, the Competition Committee will select the Competition Winners, who completed the competition task and fulfilled the remaining conditions of the Competition. The Committee will evaluate creativity, originality, and relevance to the theme of celebrating Prouvé’s 7th anniversary, and based on this, award the respective prizes.
- 3.5.** The Contest Committee will contact the Contest Winners via the social network Instagram.
- 3.6.** Winners of the Contest are required to provide the Organizer with their data in order to deliver the prize.

- 3.7. The Organizer reserves the right to verify the Winner's data.
- 3.8. The Organizer declares that the prize is not convertible into any other benefit, in particular, the Organizer does not pay the amount equivalent to the prize.

#### 4. What are the rules for filing a complaint?

- 4.1. Complaints may be submitted by mail to the following address: Prouvé sp. z o.o. sp. k., 56H Wyścigowa Street, 53-012 Wrocław, or by e-mail to: [marketing@prouve.com](mailto:marketing@prouve.com), each time with the note "COMPLAINTS - COMPETITION".
- 4.2. The complaint should state:
  - 4.2.1. first and last name,
  - 4.2.2. email address,
  - 4.2.3. describe the reason for the complaint.
- 4.3. The Organizer shall consider the complaint within 7 days from the date of its receipt and shall notify the person who submitted the complaint of the manner of its consideration in electronic form, to the e-mail address indicated in the complaint submission.

#### 5. How do we process personal data?

- 5.1. The administrator of the Participant's personal data processed as part of this Contest is Prouvé spółka z ograniczoną odpowiedzialnością sp. k. with its registered office in Wrocław (postal code 53-012) at 56 H Wyścigowa Street, entered in the Register of Entrepreneurs of the National Court Register kept by the District Court for Wrocław-Fabryczna in Wrocław, VI Economic Department under the National Court Register number: 0000665414, NIP: 8992810863, REGON: 366657707.
- 5.2. The Participant's personal data (name and surname, address of residence or mailing address, e-mail address, telephone number, other contact data) will be processed only for the purposes related to the proper conduct, including announcement of the results of the Contest and issuance of Prizes and its documentation. Provision of personal data by the Participant is voluntary, however, it is a condition for taking part in the Contest.
- 5.3. The legal basis for the processing of the Participant's personal data is Article 6(1)(a) GDPR (consent to the processing of personal data) or Article 6(1)(f) GDPR (processing of the Participant's personal data is necessary for the conduct of the Contest with the Participant's participation, for the investigation of possible claims or defense against claims).
- 5.4. The Participant's personal data will be processed during and after the Contest for the period required by law or the period of limitation of claims.
- 5.5. The Participant's personal data may be disclosed to persons authorized by the Organizer or to entities processing personal data on behalf of the Organizer, including those performing services on behalf of the Organizer, as well as to other

persons, entities and bodies to the extent and in accordance with the rules of law.

- 5.6. Participant's personal data will not be transferred to third countries or international organizations and will not be used for automated decision-making, including profiling.
- 5.7. The Participant has the right to access his or her personal data and to request the Organizer to correct, delete or limit its processing, the right to transfer personal data, the right to withdraw consent to the processing of personal data, or the right to object to the processing of personal data, as well as the right to lodge a complaint to the supervisory authority (the President of the Personal Data Protection Office, 2 Stawki Street, 00-193 Warsaw) if it is determined that the processing of the Participant's personal data violates the law.

#### 6. What else do we want to inform you about?

- 6.1. The regulations are effective as of 07.05.2024 r.
- 6.2. The Participant may be excluded by the Organizer from participation in the Contest if the Participant violates the provisions of the Regulations.
- 6.3. The headings have been used in the Regulations for organizational purposes and will not affect the interpretation of its provisions.
- 6.4. In matters not regulated by the provisions of the Regulations, the provisions of generally applicable Polish law shall apply.
